Highly Skilled Migrants in Global Cities (SKIM): Exploring Complex Pathways, Motivations, and Experiences

Global cities are at the epicenter of the knowledge economy, investing aggressively in strategies such as urban marketing, establishment of new creative clusters, urban regeneration, in order to draw talent essential for innovation and growth. While the drive to attract hypermobile professionals once

targeted predominantly affluent expats from the Global North, the cohort of these professionals has now diversified, encompassing a broader range of professions, origins, genders, and migration routes that span both the Global North and South. This new reality calls for a rethinking of the motivations and settlement experiences of these highly skilled migrants. The current limited understanding of their aspirations, pathways, and multifaceted life experiences is a significant impediment for urban planners, policymakers, and businesses aiming to effectively attract and sustain this talent. Our research aims to address this gap by leveraging innovative methods such as online ethnography, virtual engagement methods, and participatory digital storytelling techniques to document the complex trajectories of hypermobile skilled migrants across a range of global cities. The project will achieve four inter-related objectives:

1) **Understanding Complex Decision-Making:** This project will unpack the intricate motivations driving multiple migrations, moving beyond rudimentary push-pull theories. We seek to understand how various factors like quality of life, citizenship prospects, and career opportunities impact these decisions and how they evolve over time.

2) **Examining Global City Strategies:** The research will assess the effectiveness of urban initiatives aimed at attracting highly skilled migrants in six cities: Toronto, Paris, Istanbul, Doha, Singapore and Hong Kong. The comparative analysis will shed light on how well these strategies align with the actual needs and aspirations of the targeted talents.

3) **Exploring the influence of Transnational Professional Fields:** We will investigate how three strategic sectors – urban infrastructure and design, the digital economy, and creative industries shape mobility patterns and international career pathways, and how the mobility of such professionals redefines the global status of cities.

4) **Investigating Personal and Professional Experiences:** Lastly, we will uncover how continuous relocations impact career development, family life, and sense of belonging. We will also examine how these experiences vary based on race, gender, and socio-economic status.

It embeds processes of responding to skill shortages: re/up skilling of established populations (incl. migrants and inactive women), raising wages, automation and migration. It considers 4 continents: Europe, Africa, Asia and America, where skill shortages and skill flows will be analysed. It develops the AI-Assisted Skill Navigator for stakeholders from employment, vocational training organisations in origins and destinations. Link4Skills will scrutinize: (a) how to identify the existing and emerging required skills in changing labour markets?; (b) how the EU should respond to skill shortages?; (c) how to recruit the required skills from various pools either from the existing workforce (including established migrant populations and inactive women) also supported by automation, and from the workforce from non-

EU countries? The project combines data on skill gaps and matching in the EU with analyses about human capital in origins; investigates emerging and established migration skill corridors between EU and India, Morocco, Ghana, Nigeria, Philippines, Indonesia, and Ukraine, in order to make enriched inventories of skill partnerships. Gaps is a comprehensive study on the drivers of return policies and barriers/enablers in international cooperation on returns. The project examines the disconnects between expectations of return policies and their actual outcomes by de-centering the dominant, one-sided understanding of "return

policymaking.” GAPS will: a) scrutinize the shortcomings of the EU’s governance of returns with both its internal and external dimensions; b) analyse enablers and barriers of international cooperation c) shed light on the perspectives of migrants themselves to understand their knowledge of return policies, aspirations, and experiences. By taking a close look at governance, cooperation and actor’s agency, the project is able to suggest new avenues for international cooperation, develop recommendations for stakeholders and explore alternative pathways to returning migrants. Abstract

Irregular migration usually exists in the margins in the Canadian immigration landscape, which has limited our understandings of the migration dynamic. While there has been some increase in information and data about the phenomena, definitions of irregular migration remain highly uncertain and contested. The Minister of Immigration, Refugees and Citizenship’s directive to explore new regularization pathways), the growing number of sanctuary jurisdictions, and the increase in civil society mobilizations around the issue, particularly since the COVID pandemic (Smith and Kim, 2022), all point to the need for a better understanding of the nature and requirements of Canada’s irregular population. Evidence is also mounting on the degree to which Canada’s irregular and precarious populations play key roles in supporting the Canadian economy, yet the country has seen little political and legislative change to recognize their contributions.

The MIRreM Canada project will undertake a critical review of the indicators, categories, measures, and policies of irregular migration in Canada, with the view to providing policymakers and +immigrant-serving providers with insights into possibilities for more targeted and productive regularization policies and programs. As an Associated Partner and member of a consortium of the umbrella, EU Horizon 2020-funded MIRreM project, MIRreM Canada will contribute to the larger project enabling rich, comparative insights between European countries, Canada, and other geographic regions, around estimation methodologies and how associated irregular migration policies do or do not work in these contexts. Abstract

The number of international students tripled in the last decade, from 285,890 in 2011 to 622,000 in 2021. Despite increasing admission levels and policy emphasis on their retention, their rate of transition to permanent residency has been low. Only about one-fifth (19%) of international students who entered Canada with a study permit between 1990 and 2014 obtained permanent status within ten years of receiving their study permits. This indicates that many students live and work with temporary status for a lengthy period. Moreover, their migration transition is often intertwined with their school to work transition. Although their temporary migration is regulated by policy, the time dimension (both quantitative and lived/experiential time) of their temporariness is ambiguous and probably changes during their studies and post-graduate employment experience. While undergraduate, masters and PhD students follow the same regulatory process of transition from temporary to permanent status, their study length, institution type, study field, gender, employment experience and life course stages shape their experiences differently.

This study – International students’ lived experiences in Canada (ISX) – brings the three stages of international students’ transition: study permit stage, postgraduate work permit stage and permanent residency stage into one analytical framework and relates their individual experiences to the macro-level institutional contexts within which they study, work and encounter challenges.

Social media use is widespread around the world, and that includes use by individuals who are in the process of migrating to a new country. Research shows that as many as 80% of immigrants to Canada as well as Canadian born use social media. Further, the Service Provider Organizations (SPOs) that help newcomers settle in Canada believe social media could improve how they connect with, and support, newcomers. Despite this alignment in principle, only 7% of services of SPOs are delivered digitally. Abstract

For Canada the pandemic is not only posing short term challenges with regards to border restrictions and quarantine arrangements aimed at protecting public health, it raises important medium and long-term risks as skilled immigration is a vital element in the country's socio-economic and demographic growth. A recent report from the Royal Bank of Canada estimates that the country will bring in "only 70% of the originally targeted 341,000 new permanent residents" in 2020 – 100,000 people will be missing from the immigration count. Migrant labour is likely to be at the forefront of the economic recovery whether through attracting foreign talent for technological or social innovation or because the migrant labour force supplies to essential sectors of the economy. In this disrupted and uncertain COVID19 world, **understanding better the drivers of international, highly-skilled migration and how the pandemic is affecting the decision making of prospective highly-skilled migrants** is key to supporting Canada's future immigration plans, economic recovery and demographic sustainability.

This project aims at filling this gap by conducting primary research on the decision making of highly skilled migrants aiming to settle in Canada. Abstract

In Canada, the systematized exploitation of migrant agricultural workers has been at the forefront of public debate, particularly during the COVID-19 pandemic, but progress in tackling this complex issue has been slow. Food supply chains are often opaque, and the challenges involve multiple policy areas. According to civil society coalitions and workers' rights organizations, a coordinated regulatory response and effective sanctions are needed to tackle the exploitation of migrant agricultural workers. However, the problem does not rest with government alone: farmers/producers, supermarkets as well as consumer power need to be harnessed to improve the living and working conditions of essential migrant workers. Efforts to date to tackle the exploitation of agricultural migrant workers have focused on regulation, notably the creation of national housing standards and the implementation of regular, unannounced inspections of farms or meat-processing/packaging plants. Less attention has been paid to the impact that consumer power and worker organizations can have on the agriculture sector, including distribution chains.

COVID-19 and the Worsening Precarity of Temporary Migrant Workers from Nepal

The proposed project examines the pressing use of the impacts of COVID-19 on the worsening precarity of temporary labour migrant workers. It uses the case of Nepal to study the consequences of the large-scale return and reintegration of migrant workers to their home countries. Nepal is the fifth most remittance-dependent economy in the world. The global pandemic will have direct economic and social consequences for the country and its migrant workers and this research aims to study those impacts. The research builds on a pilot study that the PI has developed in early 2021 in Nepal looking at 40 returnee migrant workers to understand the circumstances of their return and their reintegration back home. This project will follow 150 returnee migrant households from different destination countries with quarterly phone interviews over an 18-month period to investigate the past migration pathways for the returnee migrants; the circumstances surrounding their return; their future aspirations. The project will also conduct 6 focus groups discussions and 10 key informant interviews with relevant stakeholders. This project engages critical with brokerage-driven temporary labour migration schemes in Asia which provide short term work opportunities and remittances for many but labour migrants usually remain excluded or only partially incorporated into labour laws and welfare support schemes in the host countries. The project advances theory in developing a critical holistic understanding of the role of different stakeholders in regulate temporary migration regimes, notably local civil society, international organisations, governments and local authorities, brokers and the private sector alongside migrants and their families.

Abstract

A powerful lever of social and economic development, migration comes with many benefits but also significant challenges. Migration governance overwhelmingly focuses on regulating (and curtailing) flows and trends and not the complex factors that drive migration. It also overlooks the dynamic nature of migrant decision-making. This situation is worsened when a global crisis in the form of a pandemic accelerates and forces many to leave, or contributes to increased inequalities especially for migrants. In this context, understanding better the drivers of international migration and developing solutions that will inform the work of governments and stakeholders is of utmost importance and can bring considerable benefits for governments, stakeholders, and migrants. Previous approaches to migration governance research have been more silo-ed, focusing on specific migration drivers (economic, political, environmental) or types of migration (humanitarian vs labour migration; international vs internal).

As its overall goal, the Complex Migration Flows and Multiple Drivers in Comparative Perspective (MEMO) research Partnership proposes to address these limitations by developing a socio-ecological systems framework that integrates the different drivers and types of migration. To this end, in this 6-year multidisciplinary project, we will focus on the following 3 specific objectives:

1. Generate new data and combine with existing evidence, to map the links between internal, intra-

regional and intercontinental migration along complex corridors of population flows in three migration systems;

2. Develop and test new analytical models that explain the interplay among migration drivers (environmental conditions, demographic and health factors, economic development dynamics, socio-political issues) taking into account also cultural and emotional processes that eventually shape people's decisions to migrate;
3. Translate research knowledge into policy-tools (by developing digital visualisation tools, interactive story-driven dashboards, and infographics modeled on approaches found in contemporary data journalism) that will support an efficient and rights-based governance of international migration.

MEMO will achieve the above by investigating 3 specific migration systems and the multiple corridors of population flows that run within them in different directions: The migration system of the Americas focusing on migration flows from the northern countries of Central America (Guatemala, Honduras and El Salvador) to Mexico and further North to the USA and Canada; the migration system of West Africa, focusing on Nigeria, Ghana, Senegal and Ivory Coast and their inter-related flows to each other, to neighbouring countries in West Africa and towards Europe and Canada; the migration system of the northeastern part of South Asia, focusing on Nepal and Bangladesh, internal and cross border flows within South Asia, as well as to Malaysia, and Canada. This Partnership consists of 37 researchers and 32 partner organisations covering 4 world regions and the multiple migration corridors within these regions.

Migration affects not just individuals but also their families, communities and countries, in their countries of origin, transition and destination (IMF, 2015). However, due to hierarchical relationships among nation-states, reinforced by discursive practices, dominant discourses on migration focus on costs and benefits for the Global North while the impact of migration on the Global South is largely ignored. The International Coalition of Research Centres in Migration (ICRCM) is proposed to challenge this inequitable relationship by drawing in voices of migration researchers from the Global South into a critical, self-reflective dialogue about migration issues with the following three objectives: a) to form an innovative partnership for the co-creation of a new integrative Global South/North knowledge base comparing families' migration experiences; b) to enhance capacity and networks of scholars in migration for collaborative international projects; and c) to systematically document, analyze, and disseminate lessons learned about developing a partnership among research centres from the Global South and Global North.

Building Resilience Against Violent Extremism and Polarisation

Far Right and Islamist groups seeking to recruit people to their particular political cause promote ‘black and white’ ideologies that lead to polarization, hatred, intolerance and violence. Often cherry-picking from religious doctrines, they rely on superficial understanding and interpretation of such doctrines. The activities of such groups can lead to disruption of social cohesion, diminished civic capacity, social tensions, hate speech, intolerance, discrimination and even violence. This project builds on existing knowledge and policy experience with a view of developing better analytical and policy tools for the design of more efficient resilience policies that counteract polarization and prevent violent extremism. The project starts with a critical reading of existing scholarly literature and with a critical mapping of existing policy approaches to develop a preliminary impact assessment of these approaches. It continues with a further survey of good practices in counteracting polarization and violent extremism and builds an integrated database of such practices. The project develops a Resilience Hub that engages with three types of factors that can promote or mitigate polarization and violent extremism in society: notably historical and cultural factors; socio-economic conditions; the role of the social media and networking. We develop stakeholder workshops in relation to these three sets of factors that affect radicalization in society, and follow up with digital forums with the participation of a large number of stakeholders. Each stakeholder dialogue builds a tool of resilience in their field: notably inter-faith education training for secondary school teachers; a proposal for a basic income policy that mitigates socio-economic inequalities; a guide to responsible social media design. The Resilience Hub further develops a Resilience Fair where arts-based community interventions to stop polarisation and build resilience will be presented.

What can Europe learn from other parts of the world about managing religious diversity? What lessons can be learned to help prevent religious radicalisation? With input from researchers in Europe, North Africa, the Middle East, South Asia and Oceania, the EU-funded GREASE project will spend the next three years exploring these questions. The twelve-partner consortium will look at how religious diversity is governed in a broad range of cultures, comparing relevant norms, laws and practices. Within this process the researchers will seek to assess the relative success of various regimes in integrating minorities and migrants. The aim is to deepen our understanding of religious diversity governance, emphasising insights for countering radicalisation trends.

In addition to comparing current models of religious diversity governance, GREASE will analyse historical influences affecting them. Specifically, the project will look at how norms and practices for governing religious diversity have been transferred between Europe and the regions mentioned above. Particular attention will be paid to the legacy of colonialism.

With respect to Europe, GREASE will attempt to unravel the paradox of religious radicalization in light of growing secularization. The project will consider the claims that migrant integration in Europe has failed because second generation youth have become marginalised and radicalised, with some turning to jihadist terrorism networks. The researchers will also examine secularisation and radicalisation in light of wider societal transformations such as increased connectivity, mobility and inter-dependence as well as widening inequalities and the re-emergence of nationalism.

As Europe struggles to cope with the challenges of religious diversity and radicalisation, it may be useful to look at how other regions deal with these issues. In doing so the GREASE project will deliver innovative academic thinking on secularisation and radicalisation and offer insights for governance of religious diversity, with a special focus on preventing radicalisation.

The project, which has a budget of 2.2 million euros, is being coordinated by Professor Anna Triandafyllidou from The European University Institute in Italy. Despite the polarization in public and policy debates generated by the post-2014 fluxes of refugees, asylum applicants and migrants, European countries need to work out an evidence-based way to deal with migration and asylum rather than a prejudice-based one. The proposed project, SIRIUS, builds on a multi-dimensional conceptual framework in which host country or political-institutional, societal and individual-related conditions function either as enablers or as barriers to migrants', refugees' and

asylum seekers' integration via the labour market. SIRIUS has three main objectives: A descriptive objective: To provide systematic evidence on post-2014 migrants, refugees and asylum applicants especially women and young people and their potential for labour market employment and, more broadly, social integration. An explanatory objective: To advance knowledge on the complexity of labour market integration for post-2014 migrants, refugees and asylum applicants, and to explore their integration potential by looking into their spatial distribution (in relation to the distribution of labour demand across the labour market), while taking into account labour market characteristics and needs in different country and socio-economic contexts. A prescriptive objective: To advance a theoretical framework for an inclusive integration agenda, outlining an optimal mix of policy pathways for labour market integration including concrete steps that Member States and other European countries along with the EU can take to ensure that migrant-integration policies and the broader system of workforce-development, training, and employment programmes support new arrivals' access to decent work opportunities and working conditions. SIRIUS has a mixed methods approach and innovative dissemination plan involving online priority action networks, film essays, festival, job fair and an applied game along with scientific and policy dialogue workshops and conferences.

Going beyond awareness on migrant exploitation in Italian agriculture: Why the system works the way it does

This study aims at providing a comprehensive insight on the reality surrounding and framing the restructuring of agricultural production in southern Italy as a way of showing that on-going dynamics are the outcome of deliberate policy and strategic choices at different levels of the agro-food value chains. Our aim is to analyse the broader framework in which migrants' and workers' rights are violated by going beyond the focus on the abuse migrant workers endure in southern Italy and on the merely repressive actions implemented by the EU and member states to counter the latter. The aim is to investigate the multiple pressures on the agriculture system caused by the restructuring of agri-food chains, growing regulation, and the factors pushing farmers to recruit migrant workers irregularly, thus profiting from their vulnerable condition.
