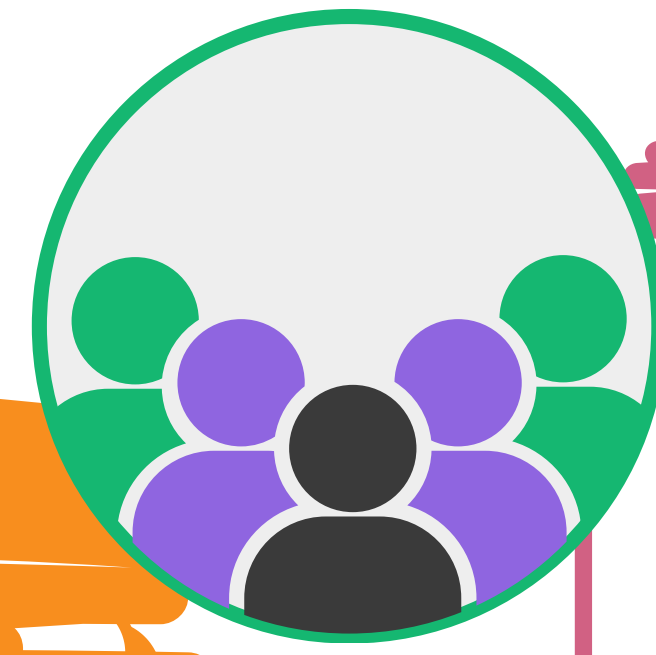


Case Study 2b: Child and Youth Activism Projects (Overview of all Five Sites)

WHO ARE WE?

ENGLISH

This Case Study focuses on our Child and Youth Activism Projects (CYAPs) in five global locations. We refer to the young participants as 'co-researchers' as they actively guide the study methods, emphasizing their autonomy and role in shaping the research process. Each of the five CYAP sites involves ten co-researchers aged 10-16 at the time of recruitment (totaling 50 young participants). Participatory action research (PAR) is used to gather qualitative data, with up to 10 PAR meetings annually held virtually, in-person, or in hybrid formats at each location. Each site has a research team comprising a lead co-investigator, an undergraduate/masters research assistant as a Facilitator, and other important team members. The CYAP sites are located in Ontario, New Brunswick, Brazil, Scotland, and South Africa.

ESPAÑOL

Este estudio de caso se centra en nuestros Proyectos de Activismo Infantil y Juvenil (CYAPs) en cinco lugares del mundo. Nos referimos a los jóvenes participantes como "co-investigadores", debido a que guían los métodos de estudio, destacando su autonomía y rol en moldear el proceso de investigación. En cada una de las cinco sedes de CYAP participan diez co-investigadores de edades entre los 10-16 años en el momento del reclutamiento (un total de 50 jóvenes participantes). La investigación-acción participativa (IAP) se utiliza para recoger datos cualitativos, con hasta 10 reuniones anuales de IAP llevadas a cabo virtualmente, en persona o en formatos híbridos en cada centro. Cada centro cuenta con un equipo de investigación formado por un co-investigador principal, un asistente de investigación de grado/posgrado como facilitador y otros miembros clave del equipo. Las sedes de CYAP se encuentran en Ontario, Nuevo Brunswick, Brasil, Escocia y Sudáfrica.

WHAT DOES OUR WORK LOOK LIKE?/HOW DO WE DO WHAT WE DO?

Participatory Action Research (PAR) infuses each CYAP site with unique dynamics. From how young co-researchers collaborate and engage to the activism issues they champion and the innovative research outputs they co-create, each location brings a distinct flavor to our global initiative. All five site teams and their valued partner agency representatives who are actively involved in recruitment and supporting the children and young people, meet generally once per month virtually to touch base about research undertakings.

WHAT WORK DO WE DO WITH THE ICCRP?

There are five (5) Child and Youth Activism Projects (CYAPs): Ontario, New Brunswick, Brazil, Scotland, and South Africa. At any time, each CYAP site involves ten (10) child and youth co-researchers that are between 10-16 years old at the time of recruitment (10 young people per CYAP location per year x 5 years x 5 locations=250).

PORTUGUÊS

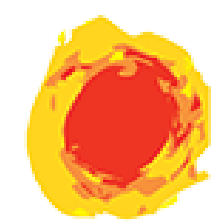
O estudo de caso enfoca em Projetos de Ativismo Infantil e Juvenil (CYAPs, na sigla em inglês) realizados em cinco localidades Ontário, New Brunswick, Brasil, Escócia e África do Sul. Os jovens participantes são designados como *copesquisadores*, uma vez que orientam ativamente e, com autonomia, os métodos de estudo e os processos da pesquisa. Cada localidade envolve a participação de dez copesquisadores com idades entre 10 e 16 anos no momento da seleção (totalizando 50 jovens participantes). A pesquisa-ação participativa (PAR) é usada para coletar dados qualitativos. São realizadas até 10 reuniões anuais nos formatos virtual, presencial ou híbrido em cada uma das localidades. Cada equipe é composta por um pesquisador-líder, um assistente de pesquisa de graduação/mestrado como facilitador, e os demais membros da equipe.
