

PUBLICATION AGREEMENT AND COPYRIGHT LICENSE

**THIS PUBLICATION AGREEMENT AND COPYRIGHT LICENSE** (the “Agreement”) is made as of the last date of signature below (the “Effective Date”) between the Toronto Metropolitan University Rubix (“Rubix”), of 350 Victoria St., Toronto, Ontario and **<AUTHOR NAME(S)>** (the “Author”), with regard to the Author’s original work entitled **<TITLE OF WORK>** (the “Content”).

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. To facilitate the publication and distribution of the Content in TMU’s open-access journal, Rubix, the Author hereby grants to TMU a non-exclusive, royalty-free, irrevocable, worldwide, sub-licensable license to produce, reproduce, copy, publish, translate, distribute and otherwise use the Content, in whole or in part, in electronic, print, audio-visual or by any and all media now or hereafter known or devised for the full term of the copyright, and all renewals and extensions thereof under the condition that the Author is given credit as the Author of the Content.
2. TMU confirms that any sublicenses of the Content will be made available to third parties under a Creative Commons Attribution-NonCommercial-NoDerivs 4.0 International (CC BY-NC-ND 4.0) license.
3. TMU confirms that the Author retains the copyright in the Content and except as set out herein, no rights in copyright patents, trademarks, or other intellectual property rights are transferred to TMU.
4. The Author grants The Rubix Journal, in addition to the rights as granted above, the exclusive right to publish the Content in The Rubix Journal in any form whatever (including print or electronic media), for a period beginning when the Agreement is executed and ending twelve (12) months after publication of the Content in Rubix. During this period of exclusivity, Rubix expressly consents herein that the Author may publish the Content, in whole or in part, on the Author’s own website(s) or the Social Science Research Network (SSRN) or similar scholarly forum that publishes working draft versions of academic works, providing that the Author indicates, on or in association with the first page of the work, that the Content is a draft that is scheduled for publication, or has been published, in Rubix. The Author agrees not to publish the Content, or any substantially similar work, in any other location until the expiry of the exclusivity period.



5. The Rubix Journal agrees to supply the Author with a final typeset version of the Content in PDF format. The Author agrees to replace any draft version of the Content posted to the Author's own website(s), the SSRN, or a similar scholarly forum with the final typeset version of the Content in PDF format within two weeks of receipt from Rubix. The Rubix Journal will make the PDF version of the Content available on Rubix's publicly accessible website.

6. The Rubix Journal agrees to affix a Creative Common licensing notice to all publications, reproductions, distributions, and communications to the public by telecommunication, translations and uses of the Content. Specifically, Rubix will affix a notice indicating, "This work is licensed under a Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 International License (CC BY-NC-ND 4.0). To view a copy of the license, visit [URL link to license]," including a web link to the appropriate license with attributes as described in s. 2 of the Agreement.

7. The Author represents and warrants that:

i) the Content is the Author's original work;

ii) all individuals who contributed to the creation of the Content are included as an author;

iii) the Content is original and has not formally been published before, has not been included in another manuscript, and is not currently under consideration or accepted for publication elsewhere, unless a republication has been discussed and approved by Rubix and the original publisher;

iv) the Content contains no defamatory, libellous or unlawful statements, does not infringe upon the rights (including without limitation the copyright, patent, or trademark rights) or the privacy of others, or does not contain material or instructions that might cause harm or injury; and

v) to the extent excerpts from copyrighted works owned by third parties are included in the Content, the Author obtained written permission from the copyright owners to enable publication in Rubix and credited the sources in the Content in accordance with standard academic practice; and

vi) the Author has the unencumbered right to grant the license granted herein.



8. The Rubix Journal reserves the right to require edits or other changes to the Content, including changes to the length of the Content, to make the work suitable for publication in Rubix. Rubix also reserves the right, in its sole discretion, not to publish the Content in Rubix, notwithstanding any previous offer of publication that was extended.

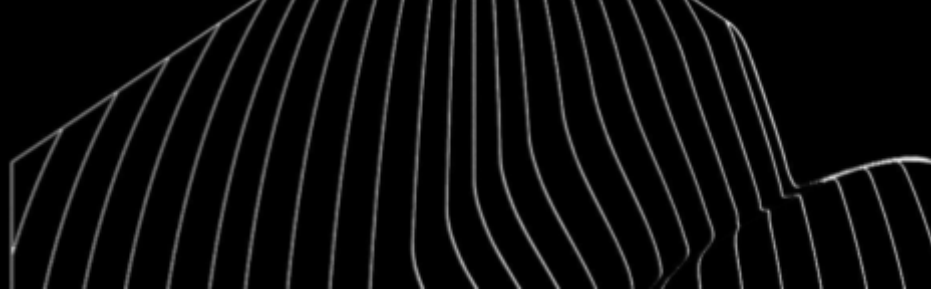
9. For s. 8 of the Agreement, all substantial changes to the Content shall require the Author's approval. The Author shall be presented with a final typeset copy of the Content for their approval before publication. The Author acknowledges and accepts that publication of the Content by Rubix may be subject to and conditional upon approval by a peer reviewer concerning the contents therein and the Author making reasonable efforts to incorporate suggested improvements to the Content by the Rubix Journal editors.

10. The Author grants Rubix, and Rubix agrees to undertake, the usual functions of copyediting the Content before publication. Unless only minor editorial changes of a typographical or grammatical nature have been made, the Author will be allowed to review and approve the manuscript before publication. All substantial changes to the Content shall require the Author's approval. If the Author fails to return the manuscript by the date set by Rubix, production may proceed without the Author's approval of the final manuscript in typeset form.

11. The Rubix Journal reserves the right to revoke this Agreement unilaterally if plagiarized material is discovered in the Content or for breach of any of the Author's warranties.

12. The Author acknowledges that they have no right to revoke the Agreement unilaterally. For greater clarity, an Author is precluded from requesting that the Content, in any form Rubix is authorized by the Agreement to publish, be removed by Rubix following publication.

13. The Author shall indemnify, defend, and hold harmless TMU, its officers, governors, employees, agents, and representatives from and against any and all losses, liabilities, damages, liens, charges, claims, demands, payments, suits, actions, recoveries, and judgements (including legal fees and expenses), as well as against any related damages, losses, liabilities, and expenses incurred by TMU resulting from any third-party claims that the Content infringes any copyright, patent, trademark, trade secret, or other intellectual property rights of a third party, contains any defamatory or unlawful statements, or otherwise results from a breach of any of the foregoing warranties or other provisions of this Agreement.



14. This Agreement constitutes the entire agreement between the parties concerning the subject matter hereof and supersedes all prior agreements, understandings, negotiations, and discussions, oral or written. The invalidity or unenforceability of any provision of this Agreement does not affect the validity or enforceability of any other provision of this Agreement, and any such invalid or unenforceable provision is deemed to be severable.

15. This Agreement is governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein. The parties attorn to the exclusive jurisdiction of the courts of the Province of Ontario and all courts competent to hear appeals therefrom.

16. This Agreement enures to the benefit of and is binding on the parties hereto and their respective successors and permitted assigns.
