

A Day in the Life of a Senior Tax Associate

We chatted recently with Calistus Alexander, an Alumni who graduated from the Ted Rogers School in 2017, and is currently working as a Senior Tax Associate in PwC.





Q:

What do you do on a 'day-to-day' basis in your role as a Senior Associate, Tax at PwC?



- Every day is different, as a Senior Associate, which is ideal in order to learn and grow. This results in an environment where new tax projects encourage active thinking and working within teams. I have had a great experience in accelerating my learning and have been exposed to various projects and clients.
- Generally, the role of most accountants is to service clients for all tax matters this
 includes personal tax, corporate tax, and trust tax issues amongst other tax-related
 work.
- Versatility is also part of my role. I am exposed to many tax concepts which are then applied to real life. It is one thing to learn a technical concept in a textbook, and another to apply your learning to a detailed application of a client's file.
- There is a strong support system at PwC from professionals who have experience in a wide range of tax. My role includes working with intelligent individuals who have been practicing in the tax industry for a long time.
- Every day includes team work and acting as a liaison between individuals, companies, families, and the firm.
- Certain times of the year require me to focus on specific types of projects. For instance, during the months of March, April and June, the work is primarily compliance-based.
- Every day is different, so it is important to adapt to the work that comes in. Adapting and being challenged, while learning, makes the job interesting.
