

Accounting Sector Expected To Grow In Next 5 Years!


While this past year has been challenging for Canadian businesses, the future looks bright!1



The accounting services sector has projected an annualized growth rate of 3.1% until 2025²




New jobs will be created as a result of growth by 2025³

Are The Big Four The Only Option?



The largest firms in Canada are often referred to as the 'top four', with Deloitte topping the list at almost 18% of the market share and \$2.33B in annual revenue.⁵

Many students think that it's these 'top four' that offer the best opportunities for CPAs, but the mid-sized and boutique accounting firms account for over 50% of the marketplace. Firms like Grant Thornton, BDO, RSM, Smythe, MNP, and many, many more.


It's Not Just Accounting Firms That Hire CPAs

Do You Know Your Acronyms? CFE and CPA?

If you wish to be a professional accountant in Canada, you need to be designated by the Chartered Professional Accounting Association (CPA). In addition to getting work experience, one needs to pass the Common Final Examination, called the CFE. It's an intense three-day assessment involving knowledge, judgement, and ethics.






Blockchain
